LIMITED WARRANTY – SERVICED PRODUCTS

THE FOLLOWING LIMITED EXPRESS WARRANTY IS EXTENDED BY MID-CONTINENT INSTRUMENT CO., INC. FOR ALL PRODUCTS SERVICED BY MID-CONTINENT INSTRUMENT CO., INC., AS A COMPONENT PART OF AN AIRPLANE.

MID-CONTINENT INSTRUMENT CO., INC. WARRANTS PRODUCTS SERVICED BY THEM TO BE FREE FROM DEFECTS IN MATERIAL AND WORKMANSHIP, WITH RESPECT TO WORK PERFORMED, AT THE TIME OF SHIPMENT, AND ARE INSTALLED AND USED UNDER RECOMMENDED CONDITIONS, AND TO PERFORM ACCORDING TO THE REQUIREMENTS OF THEIR INDIVIDUAL SPECIFICATIONS. ANY DEFECT, MALFUNCTION, OR FAILURE, OF A MID-CONTINENT INSTRUMENT CO., INC., SERVICED PRODUCT CAUSED BY DAMAGE (NOT RESULTING FROM DEFECT OR MALFUNCTION) WHILE IN THE POSSESSION OF A BUYER, OR UNREASONABLE USE (INCLUDING FAILURE TO PROVIDE REASONABLE AND NECESSARY MAINTENANCE), SHALL NOT BE COVERED BY THIS WARRANTY.

EXCEPT FOR A WARRANTY OF TITLE AND THE LIMITED WARRANTY SET FORTH ABOVE, NO OTHER WARRANTIES, EXPRESS OR IMPLIED OR OTHER OBLIGATIONS OR LIABILITIES SHALL APPLY. IN NO EVENT WILL SELLER BE LIABLE FOR ANY INCIDENTAL DAMAGES, CONSEQUENTIAL DAMAGES, SPECIAL DAMAGES, INDIRECT DAMAGES, LOSS OF PROFITS, LOSS OF REVENUES, OR LOSS OF USE, EVEN IF INFORMED OF THE POSSIBILITY OF SUCH DAMAGES. SELLER'S LIABILITY FOR DAMAGES ARISING OUT OF, OR RELATING TO A PRODUCT OR ORDER, IS LIMITED TO THE LOWER OF CATALOG OR CONTRACT PRICE FOR THE SPECIFIC PRODUCT THAT GIVES RISE TO THE CLAIM. TO THE EXTENT PERMITTED BY APPLICABLE LAW, THESE LIMITATIONS AND EXCLUSIONS WILL APPLY REGARDLESS OF WHETHER LIABILITY ARISES FROM BREACH OF CONTRACT, WARRANTY, TORT (INCLUDING BUT NOT LIMITED TO NEGLIGENCE), BY OPERATION OR LAW, OR OTHERWISE.

MID-CONTINENT INSTRUMENT CO., INC. WARRANTS **ALL EXCHANGES AND OVERHAULS FOR ONE (1) YEAR FROM THE DATE OF SALE OR EIGHT HUNDRED (800) HOURS OF OPERATION, WHICHEVER OCCURS FIRST. ALL REPAIRS INCLUDE A NINETY (90) DAY LIMITED WARRANTY.** WE WILL REPAIR OR REPLACE, AT MID-CONTINENT INSTRUMENT CO., INC. OPTION, A DEFECTIVE UNIT UNDER WARRANTY ONCE THE UNIT IS RETURNED AND WE VERIFY THE MALFUNCTION. AFTER REPAIR OR REPLACEMENT, ITEMS UNDER WARRANTY RETAIN THE UNUSED PORTION OF THE ORIGINAL WARRANTY. THE DEFECTIVE PRODUCT SHALL BE RETURNED, PROPERLY PACKAGED, POSTAGE PREPAID TO:

GYROSCOPIC PRODUCTS OVERHAULED BY MID-CONTINENT INSTRUMENT CO., INC., HAVE A STORAGE TIME LIMIT OF SIX (6) MONTHS. DURING STORAGE, SAID PRODUCTS MUST BE MAINTAINED WITH REASONABLE CARE, ADEQUATE PACKING, AND STORED IN DRY AREAS WITH TEMPERATURE ENVIRONMENTS BETWEEN LIMITS OF 60 DEGREES FAHRENHEIT AND 100 DEGREES FAHRENHEIT. THE ORIGINAL SHIPPING DATE OF THE PRODUCT WILL BE THE BASIS FOR DETERMINING THE BEGINNING OF STORED TIME. IF THE SIX (6) MONTH STORAGE TIME HAS BEEN EXCEEDED ON GYROSCOPIC PRODUCTS, THE UNIT MUST BE EXERCISED AND BENCH TESTED PRIOR TO INSTALLATION IN THE AIRCRAFT. FAILURE TO COMPLY WITH THESE REQUIREMENTS CONSTITUTES UNREASONABLE USE UNDER PARAGRAPH 1.

FOR THE PURPOSE OF THIS WARRANTY, NO PART OVERHAULED BY MID-CONTINENT INSTRUMENT CO., INC., WILL BE REGARDED AS DEFECTIVE MERELY BECAUSE, SUBSEQUENT TO ITS DELIVERY, SOME MODIFICATION OR ALTERATION BECOMES NECESSARY FOR PRODUCT IMPROVEMENT OR IN ORDER TO MEET A CHANGE IN THE REQUIREMENTS OF ANY APPLICABLE FEDERAL AVIATION ADMINISTRATION REGULATION.
